Recall Description

Hyundai is conducting a recall to update the Engine Control Module (ECM) software on certain Model Year 2011 through 2013 Elantra Sedan, and on certain Model Year 2013 Elantra Coupe and Elantra GT vehicles equipped with 1.8l engines. During vehicle operation, vehicles may exhibit an issue with the control of levels of Oxides of Nitrogen (NOx) in their exhaust, exceeding allowable limits.

Recall Description

In some vehicles, the brake pedal stopper material may be deteriorated. This may cause unintended illumination of the stop lamp, traction control warning lamp, activation of the engine management system's brake override feature, and/or movement of the shift lever out of Park without depressing the brake pedal. Correction: Dealers will replace the brake pedal stopper pad.

Recall Description

Issue: Hyundai Auto Canada is conducting a Special Service Campaign that provides anti-corrosion treatment to certain underbody components. Over time, components under the vehicle, including brake lines could corrode. In extreme cases, a brake line could fail and leak. A brake fluid leak can result in reduced braking. Safety Risk: Reduced braking can cause an extended stopping distance and increase the risk of a crash. Corrective Actions: Hyundai will notify owners by mail and advise you to take your vehicle to a dealership to inspect the underbody, including the brake lines. The dealer will apply an anti-corrosion treatment to certain parts, and replace the brake lines if necessary.

Recall #: R0246-1 | Anti-lock Brake System (ABS) Module Recall Date: 2024 Jun 21

Recall Description

Issue: On certain vehicles, brake fluid could leak into the control module for the antilock brake system (ABS) and cause it to short circuit. Safety Risk: A short circuit could create a fire risk, even while the vehicle is parked and turned off. Corrective Actions: Hyundai Canada will notify owners by mail and advise you to take your vehicle to a dealership to replace the fuse for the ABS module. Hyundai Canada recommends that you should park your vehicle outdoors and away from other vehicles or structures until the recall repairs have been completed.
